WYOMING AGRICULTURE IN THE CLASSROOM - ANNUAL REPORT 2021

Dear Friends,

It is with a full heart that I would like to say thank you and, in full disclosure, a goodbye as I transition out of Wyoming Agriculture in the Classroom. When I was hired in 2011, I was given three big goals: 1) create a curriculum, 2) have regional support for educators through growing a team, and 3) raise significant funding to ensure the organization's sustainability.

As we closed 2021 and rounded into 2022, we met all three goals. I intentionally use we, because the 'we' as I leave is what I will miss most. The people who have helped build, shape, and invest in this organization are unique. The beauty of this state is our people and the legacy of character they fight for in small and big ways. The genuine care that is evident for our students, communities, and the future of this great state leaves me breathless. What a gift and honor it has been to facilitate something so remarkable and long-lasting, not only for today but for our students from the most rural to growing towns.

Thank you for embarking on this 2nd-5th Grade journey with us. Initially, as we researched where we should start, it was clear that elementary school must be the target. If students cannot name, roleplay, or even see a career, they won't choose it. To keep our students in Wyoming, we needed them to know Wyoming. We concentrated on teaching critical thinking skills and honed student-led work. The beauty was watching industry, and education communities collaborate to create an engaging, living lesson, for our students to experience. And at the heart of it all, has been stewardship. Through these powerful lessons, students can grapple with what it means to be a steward in their home, school, community, and state.

I have traveled to the classrooms, I have watched the lessons in action, and I can tell you undoubtedly – the goals met were not just targets on paper – but pivoting the direction of our community leaders in the next few decades. You made this all possible through your support.

Writing thank you does not feel sufficient to cover the gratefulness in my heart. As we fought to make these things happen, you opened your homes to meet, provided wisdom, and invested in the future concept we painted for Wyoming. I am in awe of what has happened, and of the possibilities to come. The current Board and staff could not be more prepared to reach the next set of goals. As I now join you as the greater community to support and encourage them, I know more success is not far away to report.

2021 BOOKMARK & BEYOND

The Bookmark & Beyond program continues to be a favorite, and it is no wonder why – the student artwork is remarkable, and the story the artwork tells is impactful for students to share not only peer-to-peer but with the Wyoming community, and beyond. In total, we received 1,605 entries.



In past years, WAIC has mailed classroom packets containing bookmark templates and Wyoming Agriculture Resources maps for each student to every 2nd-5th Grade classroom in Wyoming. Recognizing a growing need to make educational resources available virtually, WAIC published all resources for the Bookmark and Beyond program on our website. A new interactive activity designed to provide a deeper understanding of the Stewardship of Wyoming's Resources, specifically those from Wyoming's core industries, has been developed and published for students to complete before drawing their bookmarks. This resource has been pivotal in providing the students with an opportunity to learn more about Wyoming's resources before creating their bookmarks. The activity features an interactive map for our three main economic industries: Agriculture, Minerals & Energy, and Outdoor Recreation & Tourism.





Student finalists were invited to a 'Party in the Park' to recognize their accomplishments. We appreciate the support of Governor Gordon, families, educators, and donors. The day was an amazing culmination of the growing program; it was a day of celebration and excitement.





2021 WYOMING STEWARDSHIP PROJECT

Thank you for supporting the Wyoming Stewardship Project, a curriculum for 2nd-5th Grade students that teaches critical thinking skills as students experience Agriculture, Minerals & Energy, and Outdoor Recreation and Tourism in Wyoming. We are excited to have increased our classroom count to 112 classrooms and are well on our way to 50% of classrooms participating by 2025. The lessons have a great impact! 

2021 EDUCATOR OF THE YEAR



Reva Lobatos, 4th Grade educator at Fort Washakie Elementary in Fremont County, was named the 2021 Educator of the Year. Ms. Lobatos is active in her school, education communities, and WAIC programs. She has been involved with writing, revising, and teaching the Wyoming Stewardship Project (WSP) over the past four years.

> Lobatos commented, "Using the Wyoming Agriculture in the Classroom materials provided my students with information about the state they live in and inspired many of them to talk their grownups into exploring more of the state. Not only have we talked about caring for the land, water, and animals... Students are becoming educators among their families as well. It is very inspiring!"

Over the past four years, Lobatos has taught the WSP to her fourth-grade students on the Wind River Indian Reservation. The lessons provide a meaningful way for Lobatos to discuss natural resources, the economic impacts of those resources, and caring for the land. This year, in her virtual classroom, Lobatos uses resources from WSP as she and her students explored Devils Tower and a Wyoming Trona mine through virtual field trips.

Reva summarized her experience, saying, "I believe in this program, I truly use it, and I am always inspired by the outcomes. I also appreciate the effort that has been put into producing such an exceptional curriculum. I am very thankful for the virtual adaptations this year!"
